nullity of the provisional The measures proceeding does the administrative invalidate infringement proceeding: Collegiate Circuit Courts

The thesis with digital registry 2026451 under the title "RES JUDICATA. THE ONE DERIVED FROM THE JUDGMENT DECLARED NULLITY THE 0 F PROCEEDING ΟF EXECUTION 0 F PROVISIONAL MEASURES CARRIED OUT BY THE MEXICAN INSTITUTE OF INDUSTRIAL PROPERTY (IMPI), DOES NOT RESULT IN THE INVALIDITY OF THE ADMINISTRATIVE INFRINGEMENT PROCEEDING INITIATED ON THE OCCASION OF SUCH PROCEEDING" was published on May 19, 2023 in the Judicial Weekly of the Federation

In such precedent, the Tenth Collegiate Court in Administrative Matters of the First Circuit ruled that the nullity of the provisional measures proceeding does not invalidate, due to res judicata, the administrative infringement declaration proceeding before the Mexican Institute of Industrial Property.

The foregoing, under the justification that the provisional measures proceeding and the infringement proceeding pursue different purposes and are processed independently. However, the evidentiary material gathered in the proceeding for provisional measures cannot be used in the subsequent infringement proceeding.
